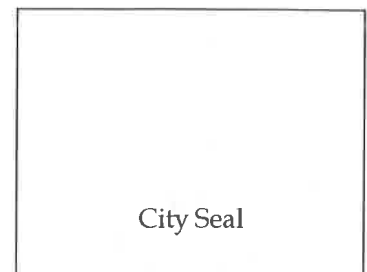

## CHAPTER 9

### LICENSE AND PUBLIC HEARING FEES ORDINANCE

#### Section 1 Purpose

The purpose of this Ordinance is to establish the license and public hearing for the City of Presque Isle.

#### Section 2 Fees

The fees for licenses and public hearings shall be as follows:

Autobody graveyard or junkyard more than 100 feet from highway	\$50.00 plus public hearing fee
Automobile graveyard or junkyard less than 100 feet from highway	\$250.00 plus public hearing fee
Automobile recycling (5-year permit)	\$250.00
Bowling alleys	\$75.00 now
Employment agency	\$100.00

Pawnbroker (Chapter 23)	\$\$100.00
Public Hearing fees	\$115.00 now/ 120.00
Refuse collection (Chapter 42)	\$100.00 per vehicle
Special amusement for dancing and entertainment (Chapter 41A)	\$40.00 Plus Public Hearing Fee

Special permit for catering off premises	\$10.00
Shooting galleries	\$10.00
Taxicab drivers (Chapter 12)	\$25.00
Taxicab service (Chapter 12)	\$100.00 per vehicle
Liquor License	\$20.00 plus the Public Hearing Fee
BYOB License	\$20.00
Marijuana Store: Annual Operation License Fee	\$2,500.00
Marijuana Manufacturing Facility: Annual Operation License Fee	\$2,500.00
Marijuana Testing Facility: Annual Operation License Fee:	\$1,000.00
Adult Use Marijuana Cultivation:	
Tier 1: 0 to 500 SF of plant canopy: Annual Permit/Licensing Fee:	\$500.00
Tier 2: 500-2,000 SF of mature plant canopy: Annual License Fee:	\$3,000.00
Tier 3: 2,001-7,000 SF of mature plant canopy: Annual License Fee:	\$10,000.00
Tier 4:> than 7,000 SF of mature plant canopy: Annual License Fee:	\$30,000.00
Medical Marijuana Cultivation: Annual Operation License Fee:	\$5,000.00
Adult Use Marijuana Nursery Cultivation: Annual License Fee:	\$350.00
Lodging Establishment Licenses Fee	\$100.00 Plus Public Hearing Fee

**Section 3 Sunset Provision**

This Ordinance shall be in force for the term of four (4) years from its effective date. This Ordinance shall become null and void upon the expiration of four (4) years from said effective date, unless recommended and required by the City Council to remain effective prior to such expiration date.
