**WARRANT AND NOTICE OF ELECTION  
CALLING MAINE SCHOOL ADMINISTRATIVE DISTRICT NO. 1  
BUDGET VALIDATION REFERENDUM  
(20-A M.R.S. § 1486)**

TO: Emalee Dyer, a resident of Maine School Administrative District No. 1 (the “District”) composed of the City of Presque Isle and the Towns of Castle Hill, Chapman, Mapleton, and Westfield, State of Maine.

**TO THE VOTERS OF PRESQUE ISLE:** You are hereby notified that a District budget validation referendum election will be held at the Sargent Family Community Center, 24 Chapman Road in the City of Presque Isle on Wednesday, May 31, 2023 for the purpose of determining the following articles:

Article 1A: To elect a moderator to preside at said meeting.

Article 1: Do you favor approving the Maine School Administrative District No. 1 budget for the upcoming school year that was adopted at the latest District budget meeting?

The voting on Article 1 shall be by secret ballot referendum. The polls will be opened immediately after election of the moderator following commencement of the meeting at 8:00 a.m. and closed at 8:00 p.m.

The Registrar of Voters shall hold office hours while the polls are open to correct any error in or change a name or address on the voting list; to accept the registration of any person eligible to vote and to accept new enrollments.

A person who is not registered as a voter may not vote in any election.
