Sealed bid proposals will be received until 2:00 P.M., prevailing time, MONDAY APRIL 29, 2024, at the office of the CITY CLERK, and at that time will be publicly opened and read, in the City Clerk's office at City Hall, 12 Second Street, Presque Isle, Maine 04769.

The work within Contract No. 1 generally consists of the construction of a 16,000 Square Foot Research Hangar which includes office as well as laboratory space complete with all necessary mechanical components to operate the facility. The building has been designed as a Pre-Engineered Metal Building on a concrete slab with associated structural foundations. There will be a separate civil bid package issued for construction of the roadway, utilities, parking lot, and associated components. Close coordination and cooperation with the contractor selected in the enabling civil bid package may be required depending upon the bid results of both packages.
